



PRIVACY POLICY

Protection of personal data according to the LOPD

Mas Gil SLU (Bodegas Clos d'Agon), in application of current regulations on the protection of personal data, informs that the personal data collected through the forms on the website: www.closdagon.com, They are included in the specific automated files of users of the company's marketing services.

The purpose of the collection and automated processing of personal data is to maintain the commercial relationship and carry out information tasks and other activities of Bodegas Clos d'Agon.

These data will only be transferred to those entities that are necessary for the sole purpose of fulfilling the purpose.

Mas Gil SLU adopts the necessary measures to guarantee the security, integrity, and confidentiality of the data in accordance with the provisions of Regulation (EU) 2016/679 of the European Parliament and of the Council, of April 27, 2016, regarding the protection of people about the processing of personal data and the free circulation of these.

Purpose of the processing of personal data:

For what purpose will we treat your personal data?

At Bodegas Clos d'Agon, we will treat your personal data collected through the website: www.closdagon.com with the following purposes:

1. In the event of contracting the goods and services offered through said website, to maintain the contractual relationship, as well as the management, administration, information, provision, and improvement of the service.
2. Sending requested information through the forms provided on the web.
3. Send bulletins (Newsletters), as well as commercial communications of promotions and / or advertising our products. We remind you that you can oppose the sending of commercial communications by any means and at any time, by sending an email to the address indicated above. The fields of these records are mandatory, and it is impossible to carry out the stated purposes if these data are not provided.

For how long is the personal data collected kept?

The personal data provided will be kept if the commercial relationship is maintained, or you do not request its deletion and during the period for which legal responsibilities may arise for the services provided.

Legitimation:

The treatment of your data is carried out with the following legal bases that legitimize it:



1. The request for information and / or the contracting of services, the terms, and conditions of which will be made available to you in any case, prior to a possible contracting.

2. Free, specific, informed, and unequivocal consent, while we inform you by making this privacy policy available to you, which, after reading it, if you agree, you can accept through a clear affirmative action, such as the marking of a box provided for this purpose in the subscription to the Newsletters service.

If you do not provide us with your data or do so in an erroneous or incomplete way, we will not be able to meet your request, making it completely impossible to provide you with the requested information or to carry out the contracting of services.

Recipients:

The data will not be communicated to any third party outside Bodegas Clos d'Agon, except legal obligation.

Data collected by users of the services:

In cases where the user includes files with personal data on the shared hosting servers, Bodegas Clos d'Agon is not responsible for the breach by the user of the RGPD.

Data retention in accordance with the LSSI:

Mas Gil SLU informs that, as a data hosting service provider and by virtue of the provisions of Law 34/2002 of July 11, on Information Society Services and Electronic Commerce (LSSI), retains for a maximum period of 12 months the essential information to identify the origin of the data hosted and the moment in which the provision of the service began. The retention of this data does not affect the secrecy of communications and they may only be used in the framework of a criminal investigation or for the safeguarding of public security, making themselves available to the judges and / or courts or to the Ministry that requires them.

The communication of data to the Forces and Bodies of the State will be made by virtue of the provisions of the regulations on personal data protection.
